**A RESOLUTION TO APPROVE AUTHORIZATION OF THE MAYOR TO EXECUTE
A TRANSPORTATION ENHANCEMENT ACTIVITIES AGREEMENT BETWEEN THE
CITY OF SANDY SPRINGS AND THE GEORGIA DEPARTMENT OF
TRANSPORTATION (GDOT) FOR MORGAN FALLS ROAD FROM MORGAN FALLS
APARTMENTS TO OVERLOOK PARK, GDOT P.I. NUMBER 0010652, CIP T-0034**

WHEREAS, it is necessary, from time to time, to establish policies, procedures and guidelines consistent with the administration of a municipal government consistent with the US Constitution, Federal Statutes, alignment with Federal and Georgia's State Constitution, and the Charter for the City of Sandy Springs; and

WHEREAS, the City of Sandy Springs (City) has represented to the Georgia Department of Transportation (GDOT), a desire to construct landscape, storm water and signage improvements at Morgan Falls Overlook Park as well as landscape on Morgan Falls Road in the City of Sandy Springs. Said improvements to be installed under GDOT Project P.I. No. 0010652, Project T-0034; and

WHEREAS, by Resolution adopted, the City of Sandy Springs (City) has entered into a Transportation Enhancement Activities Agreement with the Department of Transportation (GDOT); and

WHEREAS, the City has represented to GDOT a desire to participate in funding the construction project with a minimum 20% local fund match, and GDOT has relied upon such representation; and

WHEREAS, GDOT has indicated a willingness to fund 80% of the proposed construction cost of the project up to a maximum of \$500,000 for the said improvements along Morgan Falls Road from Morgan Falls Apartments to Overlook Park, with GDOT funds, Federal Highway Administration funds, local funds or a combination from any of the above sources; and

WHEREAS, the City desires to enter into a Transportation Enhancement Activities Agreement with GDOT; and

WHEREAS, upon adoption of this Resolution, the City will locally let and construct this project.




