RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SANDY SPRINGS, GEORGIA, TO APPROVE A MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF SANDY SPRINGS AND THE FEDERAL BUREAU OF INVESTIGATION - AMMO VIOLENT CRIME TASK FORCE AND TO AUTHORIZE THE CITY MANAGER TO EXECUTE THE SAME

WHEREAS, the mission of the Atlanta Metropolitan Major Offenders (“AMMO”) Violent Crime Task Force (“VCTF”) is to identify and target for prosecution individuals and criminal enterprise groups responsible for violations of state and/or federal law, such as violent crimes occurring in a public place, mass killings, carjacking, robbery, kidnapping and firearms violations, as well as pursue dangerous fugitives where there is or may be a federal investigative interest; and

WHEREAS, the VCTF will enhance the effectiveness of federal, state, and local law enforcement resources through well-coordinated investigations seeking the most effective investigative/prosecutive avenues by which to convict and incarcerate dangerous offenders; and

WHEREAS, the VCTF is currently staffed by FBI personnel and task force officers (“TFO”) from the City of Atlanta Police Department; and

WHEREAS, to expand its impact, the FBI has decided to offer positions to personnel in other metro agencies outside the City of Atlanta, including the City of Sandy Springs (“City”); and

WHEREAS, the FBI desires to offer a position to a detective in the City’s Police Department to serve as a TFO in the VCTF upon the terms and conditions stated in the attached MOU; and

WHEREAS, the City has determined that entering into the attached MOU is in the best interest of the general public and the citizens of the City; and

WHEREAS, the FBI desires to offer a position to a detective in the City’s Police Department to serve as a TFO in the VCTF and the City desires to participate in the VCTF upon the terms and conditions stated in the attached MOU and in the attached Cost Reimbursement Agreement (“CRA”).

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Sandy Springs, Georgia, while in regular session on February 20, 2018 at 6:00 p.m., that:

1. The MOU is hereby approved in substantially the form attached hereto; and
2. The CRA is hereby approved in substantially the form attached hereto; and
3. The City Manager is hereby authorized to execute the MOU and the CRA in substantially the forms attached hereto; and
4. The City Manager and the City Attorney are hereby authorized to make such minor revisions to the attached MOU and CRA as may be deemed necessary to effectuate the intent of this Resolution.
