**A RESOLUTION TO RENAME CENTRAL PARK WEST TO CENTRAL PARKWAY  
(FROM PEACHTREE DUNWOODY ROAD TO CENTRAL PARKWAY) AND  
CENTRAL PARKWAY TO CENTRAL PARK DRIVE (FROM PEACHTREE  
DUNWOODY ROAD TO THE INTERSECTION OF CENTRAL PARK WEST)**

**WHEREAS**, Central Park West is located in Land Lots 18 and 19, 17<sup>th</sup> District, Sandy Springs, Fulton County, Georgia, to the east side of Peachtree Dunwoody Road and travels east before intersecting with Central Parkway; and

**WHEREAS**, Central Parkway is located in Land Lots 18 and 19, 17<sup>th</sup> District, Sandy Springs, Fulton County, Georgia, to the east side of Peachtree Dunwoody Road and travels northeast before intersecting with Central Park West; and

**WHEREAS**, Cox Enterprises, LLC petitioned the City with regards to the desire to change the name of Central Park West to Central Parkway (from Peachtree Dunwoody Road to Central Parkway) and Central Parkway (from Peachtree Dunwoody Road to the intersection of Central Park West) to Central Park Drive; and

**WHEREAS**, Central Park West was realigned during the construction of the Cox C-Tech project. The realignment creates a continuous road with Central Park West and Central Parkway.

**WHEREAS**, Cox Enterprises, LLC selected to keep with the theme of the Cox Central Park campus; and

**WHEREAS**, the staff has reviewed the material submitted and determined that all property owners immediately affected by the proposed street name change have been notified of the change, and the staff has determined that there is currently no Central Park Drive within the City; and

**NOW, THEREFORE**, to accomplish the foregoing, the Mayor and City Council of the City of Sandy Springs, Georgia, pursuant to their authority, do hereby adopt the following Resolution:

1.

The Mayor and City Council of the City of Sandy Springs do hereby approve the street name change of Central Park West to Central Parkway (from Peachtree Dunwoody Road to Central Parkway) and Central Parkway (from Peachtree Dunwoody Road to the intersection of Central Park West) to Central Park Drive.

The street names shall be changed in accordance with Exhibit 1, as attached to this resolution.
