A RESOLUTION TO ACCEPT THE PROPERTY LOCATED IN THE GREENWAY – ABERNATHY ROAD LINEAR PARK PROJECT CORRIDOR, IN THE 17TH DISTRICT, CITY OF SANDY SPRINGS, FULTON COUNTY, GEORGIA

WHEREAS, it is necessary, from time to time, to establish policies, procedures and guidelines consistent with the administration of a municipal government consistent with the US Constitution, Federal Statutes, alignment with Federal, Georgia's State Constitution, and the Charter for the City of Sandy Springs, and

WHEREAS, the City Manager directed the Department of Public Works to develop standard policies for recurring matters, to establish appropriate internal controls and legal compliance, and to provide for an efficient and effective means to serve constituents; and

WHEREAS, the Department of Public Works, in response to the guidance provided by the City Manager, has reviewed and approves the acceptance by the City of Sandy Springs of City purchased property (Parcels as labeled on the GDOT project plans and on City project maps: 74P, 78P, 79P, 80P, 81P, 84P, 85P, 86P, 87P, 89P, 91P, 95P, 97P, 103P, 105P, 107P, 109P, 111P, 114P, 116P, 117P, 119P, 120P, 122P, and 123P), along Abernathy Road between Johnson Ferry Road and Roswell Road in the 17th District, City of Sandy Springs, Fulton County, Georgia, for the purpose of building a linear park, and

WHEREAS, upon adoption of this Resolution, staff will incorporate the maintenance of the acquired property into the City's park management program to effectuate the management of Department of Recreation and Parks policies.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SANDY SPRINGS, GEORGIA

That they approve the acceptance of the City purchased property along Abernathy Road between Johnson Ferry Road and Roswell Road, in the 17th District, for the purpose of building a linear park.

It is further affirmed that the property owners have been justly compensated by the City and there is no further financial impact to the City of Sandy Springs, other than the costs related to the recording of the documents and the maintenance of the City's right-of-way.

To facilitate the Greenway – Abernathy Road Linear Park Project, the City authorizes the acceptance of purchased property along Abernathy Road, in the 17th District, City of Sandy Springs, Fulton County, Georgia.
