

**A RESOLUTION TO ACCEPT CONVEYANCE OF TEMPORARY DRIVEWAY EASEMENTS
LOCATED ON LAND LOTS 164 AND 165 OF THE 17TH DISTRICT, CITY OF SANDY SPRINGS,
FULTON COUNTY, GEORGIA**

WHEREAS, it is necessary, from time to time, to establish policies, procedures and guidelines consistent with the administration of a municipal government consistent with the US Constitution, Federal Statutes, alignment with Federal, Georgia's State Constitution, and the Charter for the City of Sandy Springs; and

WHEREAS, the Department of Public Works, in response to the guidance provided by the City Manager, has reviewed and approves the acceptance by the City of Sandy Springs the Temporary Driveway Easements located on Land Lots 164 and 165, of the 17th District, Fulton County, Georgia, and more particularly described on Exhibit "A" hereto and incorporated herein by reference owned by the Holy Innocents Episcopal School, Inc.

WHEREAS the City Manager directed the Department of Public Works to develop standard policies for recurring matters, to establish appropriate internal controls and legal compliance, and to provide for an efficient and effective means to serve constituents; and

WHEREAS, upon adoption of this Resolution, staff will execute construction of driveway tie-ins in support of Project T-0007, Mt. Vernon Parkway Sidewalks in accordance with Department of Public Works' policies; and

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY
OF SANDY SPRINGS, GEORGIA**

That the City of Sandy Springs City Council and the Mayor receive, accept, and affirm the conveyance of the temporary driveway easements on Land Lots 164 and 165, of the 17th District, Fulton County, Georgia, and more particularly described on Exhibit "A" hereto and incorporated herein by reference owned by the persons listed in Exhibit "A".

It is further affirmed that the temporary driveway easements are being conveyed to the City by the property owners, and there is no financial impact to the City of Sandy Springs, other than the costs already bid and approved by the City to construct Project T-0007, Mt. Vernon Parkway Sidewalk and Traffic Calming.


