**A RESOLUTION TO AMEND THE CITY OF SANDY SPRINGS' FEE SCHEDULE -
BUSINESS LICENSE FEES-EXHIBIT B, PERTAINING TO TAXICABS, ADULT
ENTERTAINMENT AND POURING PERMIT FEES**

WHEREAS, it was the intent of the City of Sandy Springs to adopt Fee Schedules consistent with those existing in Fulton County in December 2005, and

WHEREAS, it has come to the attention of the City of Sandy Springs that certain portions of the Fulton County Fee Schedules existing in December 2005 were not published and made available for adoption by the City of Sandy Springs, and

WHEREAS, it is determined to be in the best interest of the City of Sandy Springs to provide consistency in the current Fee Schedule with the Fee Schedule existing in Fulton County at the time of the City's incorporation,

BE IT RESOLVED by the City Council for the City of Sandy Springs, Georgia while in regular session on July 5, 2006 at 7:00 p.m. as follows:


SECTION 1. That the current City of Sandy Springs' Fee Schedule (Attachment "A") is hereby amended to increase Taxicab Fees and Taxi Driver's Permit Fees to be comparable to those of Fulton County; and

SECTION 2. That the current City of Sandy Springs' Fee Schedule (Attachment "A") is hereby amended to establish and include Permit Fees for Employees of Adult Entertainment establishments, Renewal Permit Fees for Adult Entertainment Employees, Adult Entertainment Employee Background Investigation Fees, and Pouring Permit Fees for employees of Alcoholic Beverage Licensees as required; and


SECTION 3. That this Resolution shall be effective upon its adoption.

EXCISE TAX	(A 3% excise tax is levied on all mixed drinks and is to be reported and paid monthly to the City of Sandy Springs. An excise tax of .22 per liter on Liquor and Wine and .05 per 12 oz. container of beer is levied and is to be reported and paid monthly to Fulton County by wholesalers)

		<p>Any person who violates the provisions of this chapter pertaining to a potentially dangerous dog will be fined not less than \$150 for a second conviction and not less than \$300 for a third conviction.</p>
		<p>Any person who violates the provisions of this chapter pertaining to a dangerous dog shall be guilty of a misdemeanor of a high and aggravated nature and will be fined not less than \$500 for a second conviction and not less than \$750 for a third conviction.</p>
<p>PARKS AND RECREATION</p>	<p>Penalties for violation of Chapter 8, Parks and Recreation</p>	<p>Any person violating the provision of this chapter or harboring, assisting or protecting a person charged with or convicted of a violation of this chapter shall be punished by a fine not to exceed \$250, by a sentence of imprisonment not exceeding 90 days, and to community service for a period not exceeding 90 days, either or both of such fines and imprisonment, or community service, at the discretion of the Municipal Court Judge.</p>
