**AN ORDINANCE TO AMEND ARTICLE 3, DEFINITIONS, OF THE CITY OF  
SANDY SPRINGS ZONING ORDINANCE**

**WHEREAS**, the Mayor and City Council of the City of Sandy Springs find that from time to time it is necessary to amend sections of the Zoning Ordinance to correct, clarify, and update the provisions of the Ordinance; and

**WHEREAS**, the Mayor and City Council find that with the recent adoption of Article 33, *Signs*, of the Zoning Ordinance, that there is a duplication of terms related to signage in Article 3 and Article 33; and

**NOW, THEREFORE**, to accomplish the foregoing, the Mayor and City Council of the City of Sandy Springs, Georgia, pursuant to their authority, do hereby adopt the following Ordinance:

Chapter 3, *Definitions*, Section 3.3, *Definitions*, Section 3.3.19, S, of the City of Sandy Springs Zoning Ordinance is hereby amended by the deletion of the following terms, and definitions included therefor, and the insertion of the "Sign. 19 or unconstitutional.




