

Week in Review: Week Ending 9-30-2016

## PUBLIC SAFETY

### SSPD

#### North District

##### Crime:

- The Unit reported four burglaries, 12 *entering autos*, three stolen vehicles and one robbery.
- Officers working a power shift wrote several search warrants last week related to the continuing *entering auto* cases within the city.
- Captain Cain attended Command College at Columbus State University.

##### Community:

- Members of the Unit met with the head of security for the Wyngate Homeowners Association in advance of an HOA meeting where safety tips will be a topic.

#### South District

##### Crime:

- A man was shot four times while standing outside at the Nevadan Apartments. A green van was seen leaving the scene after the shooting. Detectives are investigating the case and motive. The victim was hospitalized in critical condition, but is expected to recover.
- A 37-year old man was carjacked in the Fountain Oaks parking lot by a Hispanic man in his 40's. The victim claimed the suspect knocked on the window, pulled a gun and demanded the victim exit the car and surrenders his keys. The victim complied. Before leaving in the victim's car, the suspect shook his victim's hand and said, "thank you."
- Officers have placed a focus on school bus violations, responding to several complaints received over the past week.
- Patrol officers stopped on a car with faulty brake lights. The smell of marijuana was evident, and indications of its use visible through the window. An ID check on the male driver indicated that he was on probation for a 2006-armed robbery. The driver fled into a wooded area adjacent to the Powers Ferry Road shopping center where the car was stopped. The female passenger was taken into custody on misdemeanor marijuana charges.

#### Street Crimes Unit (SCU)

- The Unit made four felony arrests, 12 misdemeanor arrests, five city ordinance arrests, 58 traffic stops, and issued 25 citations. The Unit located three wanted persons, conducted 10 suspicious person/vehicle stops, and seized 39 grams of marijuana, three grams of cocaine, and 2.8 grams of methamphetamine.
- Members of the Street Crimes Unit conducted an *entering auto* detail in the north district residential areas.

#### Special Investigations Unit (SIU)

- SIU assisted the US Postal Inspector on a postal case involving a female suspected of ordering Pentobarbital from China. The suspect admitted during questioning that she orders the drug for medicinal purposes. No product was located. The USPIS investigation continues.

#### Traffic Unit

- The Unit made four misdemeanor arrests, conducted 106 traffic stops and issued 146 citations. The Unit made three DUI arrests and spent 12 hours working traffic complaints.
- TRV 1 and 2 impounded seven vehicles, worked 17 crash calls, and conducted 22 patrol assists. The Unit changed 14 flat tires, dispensed seven gallons of gasoline, and worked 129 self-initiated calls, covering 955 miles.

- Deputy Chief Zgonc and Captain Mullin attended the Riverside Homeowners Association community meeting focused on a discussion about traffic and the Braves.
- Traffic officers conducted enforcement at numerous locations including:

- Members of the Unit responded to the I-285 accident eastbound at Roswell Road which included serious injuries.

#### K9 Unit

- The Unit made two felony arrests, one city ordinance arrest, and conducted 28 traffic stops. The Unit issued 26 traffic citations, worked one suspicious person/vehicle stop, and located one wanted person. There were two K9 tracks (people), and more than 60 K9 searches (things). The Unit worked three hours of surveillance and seized 20 grams of marijuana and one gram of cocaine.
- Officers Hanse and Stark conducted multiple vehicle sniffs at Northview High School in Johns Creek. Fifty-five vehicles were sniffed with no alerts.
- Officers Hanse and Stark assisted Dunwoody PD with a foot chase for a burglary suspect at Dunwoody Crossing. The K9s were deployed, but the suspect was not located.
- Officer Stark assisted the Special Investigations Unit with a K9 sniff of a vehicle. K9 "Renzo" alerted to the vehicle, and one gram of crack cocaine was located. Two arrests were made.
- Officer Stark assisted the Special Investigations Unit with surveillance at an apartment complex. K9 "Renzo" alerted to three areas inside the target apartment, and marijuana was located.
- Officer Reynnells made a traffic stop, arresting the driver who was wanted on a felony charge out of Athens Clarke County.

#### Criminal Investigations Division

- Prints were lifted and a preliminary identification was made related to an *entering auto* suspect through the Integrated Automated Fingerprint Identification System, a national automated fingerprint identification and criminal history system maintained by the Federal Bureau of Investigation.
- Arrest warrants were obtained for three suspects passing forged checks at Bank South.
- A felony *Theft by Taking* arrest warrant was obtained on a suspect wanted in two states. The suspect submitted a NSF check to the victim to pay for services; the victim also provided the suspect cash, which the suspect failed to re-pay.
- A victim was able to track his Tesla stolen during an overnight theft and Atlanta Police recovered the vehicle. Two males walking in a nearby parking lot were stopped, with one fleeing the scene. Video from the mall where the vehicle was located showed one of the two suspects walking away from the vehicle prior to it being recovered. A search warrant is underway for the suspect's cell phone, which could help to place him at the theft location.
- A 22-year-old male was shot outside of a leasing office on Glenridge Drive. Witnesses observed the victim next to a Chevy Astro van, apparently talking to the occupant(s). The victim was shot,

and the van took off. Cell phone records indicate the victim may have arranged the meeting with the van occupants.

- The Unit reported two burglaries and one *entering auto* around 6969 Roswell Road. The description of the perpetrator matches that of a juvenile who was arrested for a series of burglaries and *entering autos* last month.

#### Community Affairs

- Citizen Police Academy training continues.

#### Volunteers:

- The Citizens on Patrol Unit worked 131 hours and conducted 20 shifts this past week. They conducted four house checks and issued 15 handicap parking citations, covering 723 miles on patrol.
- The Unit handled seven Private Property accidents, distributing SR13 forms.

Total alarms: 93, False alarms: 89, Calls for Service (CFS): 2204, Citizen Initiated CFS: 804, Officer Initiated CFS: 1400, and Accidents: 157

## SSFR

#### Operations:

- Responded to a total of 247 calls: Seven fires, 87 EMS calls, 26 Service Calls, 86 Good Intent Calls, and 26 False Alarms
- Crews responded to a suspected structure fire in the 6800 block of Glenridge Drive. The apartment owner indicated smoke was coming from her washing machine. Crews determined the motor was overheated.
- Crews responded to an underground natural gas line ruptured in the 5600 block of Roswell Road. Tenants were evacuated. Atlanta Natural Gas assessed the situation while additional fire crews were requested for leak mitigation.
- Crews responded to a multi-vehicle accident on Interstate 285 east bound, (east of Roswell Road) which impacted four lanes. An Air Ambulance was requested to scene to assist.

#### Inspections:

- There were 204 inspections conducted with 305 violations cited.

#### Training:

- In-service training continues which includes: live fire training, high-rise training, tactical ventilation, and multi-agency training with DeKalb County Fire.
- An AEMT Practical Class was conducted.
- Fire Warden training was held for 72 individuals.
- Six car seats were inspected with three adults trained.

#### Safety Education & Public Relations Events:

- Three Fire Safety Education events were held with 169 participants: one Pre-K Fire Safety Education event and two Birthday Parties.

#### Public Information:

- Medical Officer Flaherty attended the 2016 UN General Assembly, providing medical support for federal assets and visiting dignitaries.

## TRANSPORTATION

### PROJECTS WITH MAJOR TRAFFIC IMPACTS

- Barfield Road: One lane is closed (near JAS), as fiber optic duct and cable is installed.
- **Powers Ferry at Heard's Road Intersection Improvement:** Lane shifts are planned in support of construction. **Motorists are urged to exercise caution when traveling through the intersection.**

The City maintains a **Road Work Advisory page** with updates on all planned lane and road closures and advisories. ## CIP

- T-8 Roswell Road Streetscape from Carpenter Drive to Hammond Drive: Construction is nearing completion on this project with much of the construction activities occurring at night. Final landscaping planned within the next two months.
- T-33 CDBG Northridge Road Lighting: Work will be completed over the next two months.
- T-46 Carpenter Drive/Cliftwood Drive at Roswell Road Intersection Improvement: Construction is underway.
- Hearsd Ferry at Raider Drive Intersection Improvement: Shoulder grading, sidewalk and curb line installation are scheduled to take place over the next few weeks.
- Powers Ferry at Hearsd Road Intersection Improvement: This project adds turn lanes at the intersection. Lane shifts will be installed soon in support of construction. **Motorists are urged to exercise caution when traveling through the intersection.** Variable message boards announcing the lane shifts are scheduled for installation on Monday.
- Sidewalk Program:
  - FY2017 Sidewalk Program: Initial scoring is complete and the results have been presented to Council for this year's Capital Sidewalk Program. Right of way donation intention statements for top tier projects may be submitted between now and November 18, 2016 to potentially improve project scores and relative ranking. Please see the most recent Sidewalk Program presentation on the City's Public Works Sidewalks page for more information.
  - Glenridge Drive at Greenland Sidewalk: Construction is planned for later this year.
  - Mt. Vernon Highway from Hunting Creek to Mt. Vernon Presbyterian School Sidewalk: Design is underway.
  - Glenridge Drive at Northland Drive: Please see the City's Sidewalk Projects website to view the concept plan.

## Transportation

- R-15155 North Fulton Comprehensive Transportation Plan
  - A joint effort between the Atlanta Regional Commission (ARC) and the six North Fulton cities is underway. The initiative provides an opportunity for the municipalities to plan together while informing the regional transportation planning process. - I-285 @ Riverside Interchange
  - The Georgia Department of Transportation (GDOT) continues its work on the dual roundabout interchange at the I-285 and Riverside Drive interchange. Public Works continues to monitor the new roundabouts from the Traffic Management Center (TMC).
- T-7150 Northridge @ Colquitt Road Signal Design
  - The signal is in operation. Public Works staff continues to monitor the signal and traffic conditions to ensure proper operation.

## Field Services

- FY 2017 Capital Resurfacing (Deep mill pavement) – A Pre-Bid was held September 13<sup>th</sup> with questions due Sept 15<sup>th</sup>. Bids are due September 27<sup>th</sup>.
- FY 2016 LMIG 2015 Capital Resurfacing – Additional striping work on Peachtree Dunwoody Road will begin Sunday, October 2<sup>nd</sup>. Work will take place in the evenings between 8:00 p.m. and 6:00 a.m. from Lake Hearn through the Glenridge Connector. Striping from the Glenridge Connector South to the city limit will occur during the day from 9:00 a.m. – 4:00 p.m. with normal traffic control.
- FY 2016 Capital Resurfacing of Morgan Falls Road – Obtaining pricing for final striping.
- Dunwoody Club Drive from Mt Vernon Road to Happy Hollow Road (City of Dunwoody) – Striping began Friday, September 30<sup>th</sup>, and includes include bike lanes on both eastbound and westbound lanes of Dunwoody Club Drive. This work is being performed under supervision of the City of Dunwoody.
- Utility Permits: Notification letters were sent to the utility providers regarding the updated city policies requiring advance notification of property owners and preconstruction meeting requirements. These changes go into effect October 10, 2016.

## NATURAL RESOURCE PROTECTION

### Stormwater

- There are 58 identified projects: four are under construction, two are under design, eight in contract development, one in right-of-way/easement acquisition, four in technical review, 37 in scope development, and the remaining pending final invoice or inspection.
- Five new drainage work requests were received last week.
- 895 and 1020 Edgewater Drive – Construction continues. There will be intermittent lane closures needed as part of this project.
- 6400 Riverside Drive - Blount Construction started construction this week.
- 430 Old Creek Road – A pipe under the road will receive spin-cast lining. A new manhole will be installed along the pipe run. Pricing is due October 6<sup>th</sup>.

- 540 Calaveras Drive —A detention pond will receive a new headwall for the outfall and an emergency spillway will be built. Pricing is due October 11<sup>th</sup>.
- 340 Keymar Court – A detention pond will have vegetation cleared out. Pricing is due October 5<sup>th</sup>.
- 6785 Lisa Lane – A detention pond will have vegetation cleared out, and a fence will be repaired. Pricing is due October 6<sup>th</sup>.
- North Powers Ferry/Cross Roads Pond #2 – A storm pipe will be replaced, and silt will be removed within the footprint of a pond. Contract recommendation is for Planners and Engineers Collaborative.
