

Week in Review: Week Ending 5-3 -2019

PUBLIC SAFETY

SSPD

North District

Crime:

- The Unit reported five *entering autos* and one burglary. The burglary occurred at the Art Institute of Atlanta.

South District

Crime:

- The Unit reported five *entering autos*, all in commercial parking areas.
- Three burglaries occurred in residential apartment complexes. In one case, the front door was forced open. Electronics were taken.
- A strong-arm robbery occurred at a sandwich shop. The on duty clerk identified the offender as a former employee.

Street Crimes Unit (SCU)

SCU

- The Unit reported one felony arrest, one misdemeanor arrest, and two city arrests. The unit conducted 20 traffic stops, issued 10 citations, and located two wanted persons. The unit made five field contacts, investigated five suspicious persons / vehicles, and conducted one vehicle search. The unit worked six drug complaints and conducted four knock and talks.
- The Unit arrested one person for disorderly conduct arrest (marijuana) at a location in the 5000 block of Roswell Road.
- A wanted person was arrested for a probation violation, with the passenger in the vehicle arrested for drugs (marijuana).

Traffic:

- The Unit reported 10 misdemeanor arrests, conducted 168 traffic stops, and issued 210 citations.

TRV:

- The Unit reported one misdemeanor arrest, conducted 15 traffic stops, and issued 19 citations. The Unit conducted one vehicle impound, worked 14 crash calls, conducted 23 patrol assists, and changed five flat tires. There were four gallons of gas dispensed, and three vehicle jumps conducted.

K-9

- The Unit reported one city arrest, conducted five traffic stops, and issued six citations. Two wanted persons were located. The Unit conducted one suspicious person/vehicle search, six K-9 searches, worked two drug complaints, and conducted five knock and talks.
 - Officers received a Flock camera alert on a vehicle involved in prior landscaping theft cases. They located the vehicle and charged the driver with Loitering & Prowling.

Criminal Investigations Division

- Gables Lane: Burglary/Simple Battery/Felony Theft by Taking/Interference with a 911 call - The victim's ex-boyfriend broke into her apartment and physically assaulted her. As the victim tried to dial 911, the offender took the phone and fled the scene. The detective obtained warrants for the burglary, simple battery, felony theft by taking, and interference with a 911 call.
- Roswell Rd: Terroristic Threats, Felony Criminal Damage to property - The victim's ex-boyfriend arrived at her apartment and demanded to be let inside. After the victim refused, the offender threatened to kill the victim and her child. He smashed the victim's windshield as he left the scene. The detective obtained warrants for making terroristic threats and felony damage to property.

- Hightower Trail: Identity Theft/Forgery/Fleeing to Elude – The offender went to the post office and attempted to cash a check belonging to a deceased person. After confronted by the clerk, the offender fled. Patrol officers located the suspect and attempted a traffic stop. The suspect refused to stop, entering a neighborhood, where he abandoned his vehicle and fled on foot. Warrants are forthcoming.
- Brantley Rd: Theft by Deception - The victim said she met the suspect through a dating website. The suspect advised that he owned a car lot. The victim stated that she visited the car lot in person and made what she believed to be a down payment on a car. After the money exchange, the suspect stopped all communication. The suspect was identified and notified of the violation. The suspect promptly returned the money before the theft could be investigated.
- Roswell Rd: Forgery - Detectives were assigned to investigate a forgery where the suspect mobile deposited a \$511.39 payroll check before cashing the same check in person at the Money Market. Detectives obtained the suspect's ID and surveillance video of the transaction. Detectives contacted the victim who advised that he was no longer willing to have the case investigated or prosecuted. Detectives contacted the suspect and requested he return the money. The suspect is a regular customer and advised he would meet with the storeowner.
- Carolwood Ln: Burglary - A residential burglary was reported where jewelry and checks were stolen. The investigation revealed that the victim's brother broke into the home and pawned some of the jewelry, also cashing a check belonging to the victim's husband. Warrants were issued for burglary.
- Roswell Rd: Burglary - The victim reported a burglary at his apartment. There was no forced entry. More than \$10,000.00 in cash, jewelry, firearms, electronics and high-end clothing were reported stolen.

Volunteers

- The Citizens on Patrol Unit worked 198 hours and conducted 24 shifts this past week.
- They conducted 11 house checks and issued nine handicap-parking citations, covering 683 patrol miles.
- They handled seven Private Property accidents and distributed SR13 forms.

Note: During the week ending June 21, there were 101 total alarms; the week ending June 14, 112 alarms were recorded. The City's True Verification ordinance took effect June 19, 2019.

SSFD

Operations:

- Responded to a total of 319 calls: Two Fires, 97 EMS calls, 51 Service Calls, 136 Good Intent Calls, and 21 False Alarms
- Units responded to reports of a trailer fire on GA-400, southbound by the MARTA off ramp. Upon arrival, the crew found a flatbed equipment hauler with light smoke coming from the passenger-side front axle. The Sandy Springs Police Department was on scene and attempted to extinguish with a dry chemical extinguisher. Fire personnel extinguished the fire with approximately 60 gallons of water through a 1.75" jump line. Crewmembers performed salvage and overhaul.
- Units responded to reports of a vehicle fire by the intersection of Rumson Road and Peachtree Road. Upon arrival, the crew pulled a 200 ft. section of 1.75" hose line and extinguished the vehicle fire.

Inspections:

- There were 153 inspections conducted with 38 violations cited.

EMS Training:

- SSFD continued department wide in-service training on heat emergencies and snakebite treatment.
- SSFD provided medical standby for the City Green Live event.
- SSFD provided medical standby for the Indian Consulate's International Yoga Day celebration.
- SSFD provided river safety and support for the High Country Paddle Board race.

Safety Education & Public Relations Events:

- SSFD oversaw seven events with 402 participants: three active shooter-training events, a station tour, community CPR, and three truck demonstration events.
- SSFD personnel inspected two car seats and trained three adults.
- CPR recertification was conducted for the Fire Corp volunteer unit.

TRANSPORTATION

PROJECTS WITH MAJOR TRAFFIC IMPACTS

The City maintains a **Road Work Advisory page** with updates on all planned lane and road closures and advisories. You can receive weekly traffic updates and emergency traffic alerts via email and/or text by signing up for **Sandy Springs Alerts**.

- The 100 Mile Hospitality Highway Ride is Sunday beginning at 7 a.m. Expect delays as bicyclists ride down SB GA 400.
- Closures along Roswell Road from Carpenter Drive to I-285, south of The Exchange at Hammond as GDOT relocates two sewer lines during overnight hours.

TSPLOST TIER ONE

TSPLOST

- TS103: Spalding/Dalrymple/Trowbridge Intersection Improvement Project: Right-of-way clearing in advance of utility relocation is underway.
- TS109 – Peachtree Dunwoody Road at Windsor Parkway. Design will proceed without westbound right turn lane on Windsor Parkway.
- TS192 – Mt Vernon Highway Corridor Project. This project provides multi-use path along Mount Vernon Highway, with intersection improvements at Glenridge Drive and Barfield Road. Meetings with the Glenview HOA were held on June 19, 2019.

TSPLOST Sidewalk Program: Design and survey work is underway for the following TSPLOST Sidewalk projects:

- TS161 Johnson Ferry Road – Harleston to Glenridge: Right-of-way acquisition efforts are underway with adjacent property owners. Construction planned to begin summer 2019.
- TS167 Brandon Mill Road – Marsh Creek to Lost Forest Drive: Right-of-way acquisition efforts are underway with adjacent property owners. Construction planned to begin summer 2019.

Capital Improvement Projects

- CC-10 Sandy Springs Circle Streetscape, Phase II: Project construction award goes before Mayor and Council on July 16, 2019.
- T-43 Glenridge Drive at Roswell Road Intersection: Construction continues.
- T-62-3 Sandy Springs Circle Streetscape from Mt. Vernon Highway to Johnson Ferry Road (west side). Design is complete and construction is planned to start in summer 2019.
- Sidewalk Program:
 - T-6019-1 Hammond Drive at Roswell Road: This project fills a small gap in sidewalk connectivity on the southeast corner of the intersection. Design and survey work are underway. Construction is planned for fall 2019.
 - T-6019-2 Blue Stone Road at Sandy Springs Place: This project fills a small gap in sidewalk connectivity on the northeast corner of the intersection. Design and survey work are underway. Construction is planned for fall 2019.

Construction

- Johnson Ferry Road - Sandy Springs Circle to Roswell Road (north side): Construction activities continue.
- Sandy Springs Circle Streetscape/Sidewalk – Westside Mt. Vernon to Johnson Ferry: This project will provide a sidewalk and associated improvements to complete a gap in the existing sidewalk network. Tree removal is scheduled the week of July 8, 2019.
- Sandy Springs Circle Streetscape, Hammond – Mt. Vernon - Advance Waterline Relocation: Construction of the waterline is substantially complete.
 - Overhead to underground utility relocations: Georgia Power is scheduled to begin the week of June 24, 2019, overlapping the beginning of the main construction project, which will begin late summer.
- Dudley Lane Sidewalk: Punch list to be completed by the end of June, 2019.
- Dudley Lane/Powers Ferry Resurfacing: Re-paving work at Powers Ferry and Dudley intersection is underway.

- City Springs Trails
 - T-62-1 Johnson Ferry Road: Construction is underway.

Traffic Services

- For Georgia Department of Transportation SR 9 Repaving Project from Atlanta city limits to I-285: Detection and striping restoration activities continue through August.
- Adaptive Signal Timing installation: Traffic contractors are conducting corridor validation on Hammond Drive between Peachtree Dunwoody Road and Glenridge Drive. The project is slated to be in full operation in fall 2019. During the project construction, there will be short-term rolling closures for the installation of signal detection and devices.
- City contractors are continuing to install rubberized speed cushions on Glenridge Drive between Glenridge/Glenlake Drive and Spalding Drive. **Glenridge Drive will be closed to through-traffic** during installation. The purpose of the project is to maintain traffic calming while improving public safety response capabilities. This project will be completed in early July.
- City contractors are refreshing stop bar, crosswalk, and roundabout striping on Glenridge Drive, Spalding Drive and Mabry Rd.
- City contractors are continuing long-line striping. Roads slated for striping include portions of Johnson Ferry Road, Windsor Parkway, Mt. Vernon Highway, and Mt. Paran Road. Raised pavement markers (RPMs) will be installed on portions of Riverside Drive, Glenridge Drive, Peachtree Dunwoody Road, and Northside Drive.

NATURAL RESOURCE PROTECTION

Stormwater

- There are 63 identified projects: eight are under construction, eight are under design, one in contract development, five in right-of-way/easement acquisition, 14 in technical review, 25 in scope development, and the remaining pending final invoice or inspection.
- Twelve new drainage work requests were received last week.
- Glenridge Drive Culvert – Headwalls will be replaced and a culvert will be lined. Contractor completed 75 percent of the culvert to provide structural stability before Fulton County Sewer began their jack and bore project.
- 600 North Harbor Drive – An emergency overflow structure will be modified and a floodwall will be built. The design engineer prepared additional options to the floodwall. Staff researching previous flooding.
- 1107 Crest Valley Drive – A cross drain has been replaced at 1100 and 1130 Crest Valley. Contractor working on identified punch list items.
- 70 Seville Chase (Design) – Utility coordination is underway. Easement access acquisition from affected property owners and Fulton County Sewer initiated by consultant.
- 8909 Roberts Drive – A storm pipe will be replaced and a swale will be cut to provide a positive outfall. Staff coordinating with Southern Company Gas ahead of construction to remove conflicting gas line. Blount is low bidder.
- 6871 Peachtree Dunwoody Road – Project is complete.
- 1180 Kingston Drive – Project is in punch list.
- 201 Mount Vernon Highway –Project placed on hold until gas line can be relocated.
- 110, 160, 200 Churchill Drive – Construction continues.
- 5690 Lake Forrest Drive, 2050 Old Dominion Road, 6017 Kayron Drive – Awaiting final invoice.
- 385 Amberidge Trail – Two structures and two pipes will be replaced. Construction began June 17.
- 185 Treadwick Drive and 1815 Spalding Drive - Construction is complete.

Environmental Court was held on June 21, 2019.

- There were 30 defendants scheduled to appear in court with 86 code, building, fire, or land violations.
 - Thirteen defendants with 31 charges were adjudicated with fines, probation or dismissals. Fines were assessed in the amount of \$6,800.

- Eight defendants with 16 charges failed to appear.
- Nine defendants with 39 charges were reset for future court dates.
