ITEM: Recommendation to enter into Contract Agreement with ProCutters Lawnscares, Inc. for Interstate Right-of-Way Maintenance Services

Background

Since July 1, 2009, the City of Sandy Springs has held a direct contract with ProCutters Lawnscares, Inc. to provide Interstate Right-of-Way Maintenance Services.

Discussion

ProCutters has been the City's contractor for mowing and litter pick-up along I-285 and SR 400 since 2009. In their current scope of work, ProCutters picks up litter and debris twice monthly and mowing once monthly during the growing season. In order to increase the service level on the interstate right of way maintenance, staff recommends splitting the mowing and litter maintenance services. For FY 2014, ProCutters Lawnscares, Inc. contract for \$220,000 would be used solely for mowing the interstate right-of-ways with litter and debris pick-up serviced under Optech RWM, LLC contact. This will increase mowing services from 7 to 11 times annually which allows for mowing approximately every 3 weeks during the growing season. This is necessary to maintain a uniform and landscaped appearance throughout the interstate right-of-ways.

Staff recommends awarding a contract extension to ProCutters Lawnscares, Inc. in the amount of \$220,000. This is the same as in FY2013 and will be used as discussed above.

Alternatives

Council could choose not to award a contract.

CONTRACT AMENDMENT

CONTRACT NUMBER AND TITLE: SERVICE AGREEMENT – MOWING SERVICES
AMENDMENT NUMBER ONE

THIS AMENDMENT to Contract is made and entered into as of the 1st day of July, 2013 by and between the CITY OF SANDY SPRINGS, (hereinafter referred to as “Sandy Springs”), and PRO CUTTERS LAWNSCAPES, INC., a corporation of the State of Georgia with offices located at 1350 Farmers Road, Conyers, Georgia (hereinafter referred to as “Contractor”).

RECITALS

WHEREAS, the City of Sandy Springs and Contractor entered into that certain contract agreement dated July 1, 2012 entitled Service Agreement, (the “Contract”);

WHEREAS, said Service Agreement provided for Contractor to provide certain Public Works Mowing Services (the “Services”) for the City;

NOW THEREFORE, in consideration of the mutual covenants set forth herein, the parties agree as follows:

I. Article IV-Term

The Parties mutually agree that the term of the Contract shall be extended for one additional year beginning July 1, 2013 through June 30, 2014.

II. Governing Law

This Amendment Number One to the original contract agreement shall be governed in all respects by the laws of the State of Georgia.

III. Entire Agreement

The Contract Agreement, as amended by this Amendment, constitutes the entire agreement between the parties with respect to the subject matter contained herein. Except for the terms and conditions of the Contract as set forth above, all prior agreements, representations, statements, negotiations, and undertakings are hereby superseded. Neither party has relied on any representation, promise, nor inducement not contained herein.

All other terms, provisions, and requirements as set forth in the Contract shall continue in full force and effect. The execution of this Amendment does not in any manner waive, settle, or modify any of the obligations of the Contractor for the work completed under the Contract. Further, the terms, provisions, and requirements of the Contract shall apply to all as set forth in this Amendment. The Contractor expressly reaffirms that all warranties and representations of the Contract Agreement continue to be true and correct and that all bonds shall cover the Corrective Work as set forth in this Amendment.

IV. Notices

All notices or other communications required or permitted to be given under this Fourth Amendment shall be in writing and shall be deemed to have been duly given when delivered personally in hand, or when mailed by certified or registered mail, return receipt requested with proper postage prepaid, addressed to the appropriate party at the following address or such other address as may be given in writing to the parties:
