Motion and Vote: Councilmember Fries moved to approve the Consent Agenda for May 1, 2012. Councilmember Sterling seconded the motion. The motion carried unanimously.

PRESENTATIONS

1. Taicang City/North Springs Charter High School

Mayor Eva Galambos called the Councilmembers and the Taicang City group to the front. The group has been visiting their counterparts at the North Springs Charter High School for the last five or six days. The Taicang group has visited many sites including the World of Coca-Cola, Georgia Aquarium, and the shopping mall. The City of Sandy Springs looks forward to continuing this relationship so that students will continue to visit Sandy Springs. She called out the names of the following students: Zhou Anqi, Tong Junjie, Chen Yalei, Shen Jaiyi, and Xing Cheng. The lead English teacher, Zhang Yan, and the Deputy Principal, Shi Bingqi, were accompanying the students. The City values the friendship of the group from Taicang.

Deputy Principal of Taicang City Mingde Senior High School Shi Bingqi, stated it is a pleasure to visit Sandy Springs and to meet Mayor Galambos again. He feels honored to meet so many Americans this time when visiting. Americans are so warm and friendly. He will bring this friendship back to China. He invited everyone to Taicang City and to Mingde Senior High School.

Zhang Yan, Lead English Teacher at Taicang City Mingde Senior High School, presented Mayor Galambos with a picture.

Mayor Galambos recognized Bing Zeng, who has been invaluable in translating and making arrangements for our visitors.

2. SAVE Award for July 21, 2011, cardiac arrest – Chief McElfish

Fire Chief Jack McElfish stated this save occurred on July, 21, 2011, when personnel from Sandy Springs Fire Rescue Station 4 crew responded to a report of a female in cardiac arrest. On scene the patient was found unresponsive and in cardiac arrest. The Sandy Springs Fire Rescue Personnel and Rural Metro Ambulance crew immediately began working together to restore circulation in the patient. Crews maintained lifesaving CPR and began advanced life support care. The patient was given several cardiac medications to help re-start her heart and the patient's heart was successfully defibrillated and restored to a normal heart rhythm. The combination of early intervention, effective CPR, highly trained personnel, and good teamwork helped create a positive outcome. The Sandy Springs Fire Rescue crewmembers that were involved in the rescue include: Fire Rescue Technician II/ Paramedic Nemanja Pavlovic, Fire Rescue Technician I/ EMT Jason Ellis, Fire Rescue Technician I/ Paramedic Jesse

Vidrine, Fire Rescue Technician I/ Paramedic Thomas Kalinowski, and Fire Rescue Technician I/ Troy Satterfield. The Rural Metro Ambulance Crew includes Paramedic/ Zachary Linscott and EMT/ Charles Livingston

Councilmember John Paulson asked if the individual who was saved was in attendance at the meeting.

Fire Chief McElfish responded no. Fire Captain Sandra Dupree tried to reach the individual, but that person has since moved.

2. SAVE Award for December 8, 2011, cardiac arrest – Chief McElfish

Fire Chief Jack McElfish stated this save occurred on December 8, 2011, when personnel from Sandy Springs Fire Rescue station 4 responded to a cardiac arrest and found a female patient unresponsive and not breathing at a local rehabilitation center. Sandy Springs Fire Rescue personnel and Rural Metro Ambulance crews arrived on scene and found the staff performing CPR. Fire and EMS crews started advanced life saving measures by securing an airway, using the CPR machine LUCAS (Machine performs effective and precise Compressions) and administering advanced cardiac medications.

Due to the specialized care of these emergency crews the patient was breathing, regained a strong pulse and responded to voices. The patient was released and made a full recovery. The Sandy Springs Fire Rescue crewmembers that were involved in the rescue include: Crew Chief/ EMT Scott McColl, Fire Rescue Technician II/ Paramedic Nemanja Pavlovic, Fire Rescue Technician I/ EMT Dustin Vaughn, Fire Rescue Technician I/ Adam Daniele, Fire Rescue Technician II/ Clinton Strong, Fire Rescue Technician I/ Paramedic Scott Seely.

4. SAVE Award for January 2, 2012, respiratory arrest – Chief McElfish

Fire Chief Jack McElfish stated this save occurred on January 2, 2012, when personnel from Sandy Springs Fire Rescue station 4 crew and Rural Metro Ambulance responded to a person experiencing trouble breathing in a residential area. On scene the crew got no response from ringing the doorbell. Our fire dispatcher advised that the patient was no longer talking on the phone line. The Sandy Springs fire crew took quick action, immediately forced the front door of the home and located the patient in a back bedroom unconscious and not breathing. The crews immediately began lifesaving measures by securing the patient's airway and breathing for them by using a Bag-valve mask to ensure proper lung inflation and to deliver high concentrations of oxygen. This crew should be commended for the quick action and excellent patient care that kept this patient from going into cardiac arrest. This patient was able to make a full recovery and enjoy a full quality of life. The Sandy Springs Fire Rescue crewmembers that were involved in the rescue include: Fire Rescue Technician II/ Paramedic Nemanja Pavlovic and Fire Rescue Technician II/ EMT Dustin Vaughn. The Rural Metro Ambulance Crew includes Paramedic/ Zachary Linscott and EMT/ Charles Livingston.


ADJOURNMENT
