**Description:** Sandy Springs Tennis Center Contract for Fulton Tennis Services Inc.

***CMO (City Manager's Office) Recommendation:***

Extend the current contract with Fulton Tennis Service, Inc. for an additional 18 months from June 30, 2011 ending December 31, 2012.

***Background:***

The Sandy Springs Tennis Center has been under contract by Fulton Tennis Services Inc. for the past five years and the city receives 4.5% of the gross income monthly. The City currently pays for electric and water service to the facility. The City extended the contract for Fulton Tennis Service, Inc. for an additional six months from January 1, 2011 – June 30, 2011.

***Discussion:***

The contractor is performing in accordance with the stipulations of the contract and has very good participation. The working relationship between the Recreation & Parks Department and the company is excellent.

***Final Impact:***

It is staff's recommendation to extend the current contract with Fulton Tennis Service, Inc. for an additional 18 months from June 30, 2011 ending December 31, 2012. The Sandy Springs Tennis Center should continue to deliver quality service to the citizens at no additional cost to the city.

## CONTRACT AMENDMENT

This Contract Amendment (the "Amendment") is made and entered into as of the \_\_\_ day of \_\_\_\_\_, 2011 by and between the CITY OF SANDY SPRINGS, a municipal corporation of the State of Georgia (hereinafter referred to as "Sandy Springs"), and Fulton Tennis Center Services Inc., a corporation of the State of Georgia (hereinafter referred to as "Contractor").

### WITNESSETH

**WHEREAS**, the City of Sandy Springs and Fulton Tennis Center Services Inc. entered into certain agreement dated July 20, 2007 entitled Fulton Tennis Center Services Inc. for the provision of certain services as described in the Contractor's Proposal dated December 1, 2005 (the "Contract"); and

**WHEREAS**, said contract agreement provided for certain enumerated Tennis Center Services with the City, ("Tennis Services")

**WHEREAS**, said Contract was extended on July 20, 2008 to modify certain provisions of the Contract and extend time for completion of those additional provisions; and

**WHEREAS**, said Contract was again modified on December 28, 2009 to extend the time of the contract to June 30, 2011; and

**WHEREAS**, the parties agree that the time of completed performance shall be extended through December 31, 2011; and

**NOW, THEREFORE**, for and in consideration of the mutual covenants contained herein, and for other good and valuable consideration, Sandy Springs and Fulton Tennis Center Services Inc. agree to amend this contract as follows:

1. Amend Paragraph 17 of the Contract to extend the term of the agreement through the date of December 31, 2012.
2. All other terms and conditions of original contract not inconsistent with this amendment shall remain in full force and effect.
