**WHEREAS**, the City of Sandy Springs, Georgia is a Georgia municipal corporation; and

**WHEREAS**, the Mayor and Council are the governing authority of the City; and

**WHEREAS**, Mayor and Council are charged with the protection of the health, safety and welfare of the citizens of Sandy Springs; and

**WHEREAS**, the City of Sandy Springs is the first and currently only city in the State of Georgia officially recognized by the League of American Bicyclists as a Bicycle Friendly Community; and

**WHEREAS**, the City has invested in its infrastructure and seen a dramatic rise in the number of bicyclists in all areas of the City; and

**WHEREAS**, the increase in bicyclists and motorists using the same corridors could potentially pose a public safety concern; and

**WHEREAS**, the Mayor and Council believe that **House Bill 180**, attached hereto and incorporated by reference, is in the best interests of the citizens of the City of Sandy Springs:

**NOW, THEREFORE BE IT RESOLVED** by the Mayor and Council of the City of Sandy Springs, Georgia, and it is hereby resolved by the authority of same, that the Mayor and Council of the City of Sandy Springs hereby support **House Bill 180** currently before the state of Georgia General Assembly which provides for an amendment to Title 40, Chapter 6, Article 3 of the **Official Code of Georgia Annotated**, relating to driving on the right side of the roadways, overtaking and passing and following too closely, so as to require the operator of a motor vehicle to leave a safe distance between such motor vehicle and a bicycle when such vehicle is passing the bicycle; to provide for a definition; and to provide for related matters.

A BILL TO BE ENTITLED  
AN ACT

1 To amend Article 3 of Chapter 6 of Title 40 of the Official Code of Georgia Annotated,  
2 relating to driving on the right side of the roadway, overtaking and passing, and following  
3 too closely, so as to designate a short title; to require the operator of a motor vehicle to leave  
4 a safe distance between such motor vehicle and a bicycle when such vehicle is passing the  
5 bicycle; to provide for a definition; to provide for related matters; to repeal conflicting laws;  
6 and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 This Act shall be known and may be cited as the "Tony Serrano Three Feet Safe Passing  
10 Act."

11 **SECTION 2.**

12 Article 3 of Chapter 6 of Title 40 of the Official Code of Georgia Annotated, relating to  
13 driving on the right side of the roadway, overtaking and passing, and following too closely,  
14 is amended by adding a new Code section to read as follows:

15 "40-6-55.

16 (a) As used in this Code section, the term 'safe distance' means not less than three feet.

17 (b) Notwithstanding any provision of this article to the contrary, when feasible, the  
18 operator of a motor vehicle, when overtaking and passing a bicycle that is proceeding in  
19 the same direction on the roadway, shall leave a safe distance between such vehicle and the  
20 bicycle and shall maintain such clearance until safely past the overtaken bicycle."

21 **SECTION 3.**

22 All laws and parts of laws in conflict with this Act are repealed.

This restriction does not limit the right of the City of Sandy Springs to use information contained in the proposal if it is obtained from another source without restriction.



## 1.0 Executive Summary

This is a Statement Of Work (SOW) for services provided by Be Bike Friendly in assessing the bicycle friendliness of the city of Sandy Springs in consideration for applying for a Bicycle Friendly Community designation from the League of American Bicyclists (LAB).

Be Bike Friendly (BBF) is uniquely qualified to address the city of Sandy Springs' desires to become a Bicycle Friendly Community (BFC). BBF's consultants are leaders in aiding communities in becoming bicycle friendly and were the spearheads that help neighboring city of Roswell become the only Bicycle Friendly Community currently in Georgia. BBF also has unique relationships with the LAB and intimately understands the criteria for becoming a BFC.

In a meeting on Mar 1 BBF findings revealed that Sandy Springs does have sufficient efforts already completed and policies that would be part of any currently designated bicycle friendly community. While BBF cannot guarantee the designation of becoming a bicycle friendly community it is BBF's opinion that the odds are weighted heavily in favor of Sandy Springs obtaining a Bicycle Friendly Community designation.

This Statement of Work describes BBF's approach to assessing bicycle friendliness for the city of Sandy Springs. The tasks estimated in this SOW are based on BBF's knowledge of the city of Sandy Springs and its close proximity to the BBF offices. The following areas will be considered and or tasks performed:

1. Currently used roads that are part of local cycling clubs weekly routes
2. Investigate possible bicycle boulevards for commuters
3. Last mile routes to the Marta Station
4. Legislation review and recommendations
5. Bicycle Counts
6. Community organizations
7. Transportation department interviews
8. Enforcement department interview
9. Council interviews
10. BFC Application review

The work is estimated to be completed in a 3 week time period and the review is expected to be no more than 4 hours in July.

## 2.0 Statement Of Work

This Statement of Work (SOW) defines the scope of work to be accomplished by Be Bike Friendly, Inc. (BBF) for the City of Sandy Springs ("Client") under the terms defined within this contract.

The obligations of Be Bike Friendly set forth in this contract will be performed by Be Bike Friendly, itself, Eric B. Broadwell will be the consulting lead and the Be Bike Friendly point of contact. The term of this agreement will begin on or after the signature date and will continue for an estimated three weeks or until deliverables are completed, whichever occurs first. The review of the BFC application will be completed prior to submission in July.

Changes to this SOW will be processed in accordance with the procedure described in section entitled *Change Control Procedure*. The investigation and the implementation of changes may result in modifications to the estimated schedule, charges, or other terms of this Project Change Request.



## 2.1 Scope

BBF is to provide certain personnel on a fixed fee basis to perform certain tasks defined within this SOW to complete a Be Bike Friendly Cyclessessment in regard to the Sandy Springs application for a Bicycle Friendly Community (BFC) designation awarded by the League of American Bicyclists. The Cyclessessment will be completed and produce a final report containing the suggested short term and long term items to enhance chances for becoming a bicycle friendly community.

## 2.2 Be Bike Friendly Responsibilities

This section describes the tasks that BBF will complete under this Statement of Work. The following are a list of tasks to be performed:

- 1) Conduct a discovery phase
  - a) Interview Transportation Department Personnel
  - b) Interview Enforcement Department Personnel
  - c) Interview local cycling organizations and individual advocates
  - d) Obtain a city map(s) detailing the city boundaries
  - e) Obtain transportation development plans
  - f) Obtain Parks and Recreation development plans
  - g) Obtain a copy of relative city legislation
- 2) Conduct Analysis
  - a) Review maps and legislation
  - b) Compile interview results
  - c) Analyze roads near the Marta station for potential bicycle boulevards
  - d) Conduct three bicycle counts consisting of 2 hour segments morning commuters, afternoon commuters and morning weekend riders.
  - e) Conduct riding analysis on various roads and capture rider automobile interaction
- 3) Develop Recommendation and Analysis Report
- 4) Review the Sandy Springs Bicycle Friendly Application prior to submission in July.

## 2.3 City of Sandy Springs Responsibilities:

This section describes the tasks that the City of Sandy Springs will complete under this Statement of Work. The following are a list of tasks to be performed:

- 1) Provide a Single Point Of Contact
- 2) Complete the requested information in Appendix A
- 3) Aid and work in partnership to help direct and prioritize the activities or tasks
- 4) Provide timely responses to BBF requests
- 5) Provide access to any related materials deemed beneficial for this Cyclessessment

## 3.0 Confidentiality Copyrights and Warranty



Be Bike Friendly and Client recognize that, during the term of this contract, both parties may have access to confidential or proprietary information belonging to the other and each desires that any such confidential and proprietary information remain confidential. Each party agrees that, for a period of one year from receipt of information from the other party hereunder, such party will use the same means it uses to protect its own confidential and proprietary information, but in any event not less than reasonable means, to prevent the disclosure and to protect the confidentiality of such information received from the other party which is identified as confidential or proprietary ("Confidential Information"). The foregoing will not prevent either party from disclosing Confidential Information which belongs to such party or is (i) already known by the recipient party without an obligation of confidentiality, (ii) publicly known or becomes publicly known through no unauthorized act of the recipient party, (iii) rightfully received from a third party, (iv) independently developed by the recipient party without use of the other party's Confidential Information, (v) disclosed without similar restrictions to a third party by the party owning Confidential Information, (vi) approved by the other party for disclosure. If Confidential Information is required to be disclosed pursuant to a requirement of a governmental authority, such Confidential Information may be disclosed pursuant to the requirement so long as the party required to disclose the Confidential Information, to the extent possible, provides the other party with timely prior notice of the requirement and coordinates with such other party in an effort to limit the nature and scope of such required disclosure. Upon written request at the termination of this contract, all documented Confidential Information (and all copies thereof) owned by the requesting party will be returned to the requesting party or will be destroyed, with written certification thereof being given to the requesting party.

Be Bike Friendly, in providing the Services under this contract, is acting only as an independent contractor, and under no circumstances will Be Bike Friendly be deemed to be in any relationship with Client carrying with it fiduciary or trust responsibilities, whether through partnership or otherwise. Be Bike Friendly does not undertake by this contract or otherwise to perform any obligation of Client, whether regulatory or contractual, or to assume any responsibility for Client' business or operations. The Be Bike Friendly personnel performing the Services will be and remain the employees of Be Bike Friendly. In performing the Services under this letter, Be Bike Friendly may use certain software, ideas, concepts, know-how, tools, techniques or other proprietary materials or information which are owned or licensed by Be Bike Friendly. In no event will Be Bike Friendly be liable for lost profits, speculative, consequential, indirect or punitive damages.

#### 4.0 Change Control

The following provides a process to follow if a change to this Statement of Work is required:

- I. A Project Change Request (PCR) will be the vehicle for communicating changes. The PCR must describe the change, the rationale for the change, and the effect the change will have on the project.
- II. Both point of contacts (POC) will review the proposed change and approve it for further investigation or reject it. BBF will specify any charges for such investigation. If the investigation is authorized, the POC will sign the PCR, which will constitute approval for the investigation charges (if any). BBF will invoice the City of Sandy Springs for any such charges. The investigation will determine the impact that the



implementation of the PCR will have on cost, schedule, and other terms and conditions of the terms of this Agreement.

- III. A written Change Authorization must be signed by both parties to authorize implementation of the investigated changes.
- IV. BBF will not be compensated for any investigation or implementation services related to a PCR until such services are approved through the Change Control Process.

## 5.0 Termination

Either party may terminate this contract by providing the other with **5** business days prior written notice of such termination. In addition, if either party materially defaults in the performance of any of its obligations under this contract, which default is not substantially cured within 5 business days after notice is given to the defaulting party specifying the default or, with respect to those defaults that cannot reasonably be cured within 5 business days, should the defaulting party fail to proceed within 5 business days to commence curing the default and thereafter to proceed with all reasonable diligence to substantially cure the default, the party not in default may, by giving written notice thereof to the defaulting party, terminate this contract as of a date specified in such notice of termination. Upon expiration or termination of this contract for any reason, Be Bike Friendly will cease to perform the Services for Client, and Client will pay to Be Bike Friendly all sums due to Be Bike Friendly as a result of the Services performed and expenses incurred (including those expenses that, instead of being concurrently billed, have been included in future payments to be made by Client) through the effective date of such expiration or termination (prorated as appropriate). Expiration or termination of this contract for any reason will not release either party from any liabilities or obligations set forth in this contract which (a) the parties have expressly agreed will survive any such expiration or termination or (b) remain to be performed or by their nature would be intended to be applicable following any such expiration or termination.

## 6.0 Charges

BBF will perform the activities described in this Statement of Work on a fixed fee basis of \$7500. We estimate that this work effort will require 3 weeks of effort. In addition, two percent of the total contract revenue will be billed as an administrative fee. Based on \$7,500 the administrative fee is \$150.00.

The fixed fee is inclusive of all travel and living expenses incurred in completing this work effort. If there are any additional expenses beyond standard travel and living expenses BBF will obtain the approval from the City Of Sandy Springs per the change control process.

BBF will invoice the City of Sandy Springs one time for the work completed. Invoices will be payable in US dollars within 15 days of receipt.

BBF will honor the fees in this SOW until April 8, 2011. Changes to this SOW processed in accordance with the Change Control Procedure may include a rate increase or schedule change.

Prices are exclusive of applicable taxes.
