AN ORDINANCE TO ADOPT THE CITY OF SANDY SPRINGS ZONING MAP

BE IT ORDAINED by the City Council for the City of Sandy Springs, Georgia while in regular session on May 18, 2010 at 7:00 p.m. as follows:

SECTION 1. That the Official Zoning Map of the City of Sandy Springs be changed to reflect amendments through March 31, 2010, to wit;

SECTION 2. That the official map referred to, on file in the Office of the City Clerk, be changed to conform with the terms of this ordinance; and
